### **Terms & conditions 2023**

## Booking/cancellation

Booking a travel arrangement with Jagt i Polen direkte ApS is binding.

Where nothing else is stated in the offer material or contracts, cancellations can only be made according to the following guidelines: If canceled earlier than 8 weeks before the departure date, 50% of the journey price per participant. If canceled later than 8 weeks before departure, the full price of the trip is paid.

Special cancellation rules apply to airline tickets, and in accordance with these rules, already issued and named airline tickets are NOT refundable.

If canceled later than 8 weeks before the departure date, the entire trip is due for payment. The liability also includes the minimum price of ordered game. In certain cases, it is necessary to book certain areas permanently, whereby cancellation is impossible. The same applies where Jagt i Polen direkte ApS otherwise contracts to third parties to ensure the completion of the arrangement. In these cases, section 9, subsection of the Package Travel Act is waived. 1, so that cancellation cannot take place. In such cases, where Jagt i Polen direkte ApS will endeavor to limit the customer's losses by rescheduling the trip, but Jagt i Polen direkte ApS cannot be held responsible if this is not successful.

# Deposit (1 Installment)

The deposit is 50% of the travel price and must be paid immediately after the order has been confirmed by Jagt i Polen direkte ApS. Deposit and any cancellation insurance must be paid according to instructions. Upon payment of the deposit, the registration is binding for the travelers.

#### 2 Rate

The remaining amount must be unsolicited in the hands of Jagt i Polen direkte ApS no later than 8 weeks before departure. Otherwise, Jagt i Polen direkte ApS has the right to cancel the trip and the deposit paid will be lost for the traveler(s). The amount

to be paid is clearly shown on your travel document. Deposit paid (1 Installment) is not refunded if the trip is canceled more than 48 hours after payment.

## Responsibility

Jagt i Polen direkte ApS acts as an agent for hunting grounds, hotels, transport companies, etc. and cannot be held responsible for changes, delays or other conditions that are a result of breach of contract, weather, force majeure, or other circumstances over which Jagt i Polen direkte ApS has no influence. To the extent that Jagt i Polen direkte ApS's liability for damages can be legally limited according to international conventions, these liability limitation rules apply. Jagt i Polen direkte ApS informs in advance about the conditions and regulations of the individual country / region, which will be the applicable ones. Jagt i Polen direkte ApS cannot change these.

#### Airlines

Different airlines have different rules for handling weapons and trophies. It is up to the individual traveler to investigate weight restrictions, handling fees, etc., which are outside Jagt i Polen direkte ApS's influence. Several airlines have already introduced a handling fee for weapons - it is beyond our influence, which is why this cannot be paid in advance. Fees are charged directly at the airports - price indication from € 50 to € 100. Normally allowed luggage weight is 20 kg - valid for the total amount of luggage incl. hunting weapons unless otherwise stated. Weight in excess of 20 kg is settled at the airports as excess weight directly to the airline or the airport.

In the event of flight delays, it is the traveler's own responsibility to raise claims against the airline. Jagt i Polen direkte ApS cooperates with Flyforsinkelse.dk and, in case of major delays, will forward information about the delay to flyforsinkelse.dk, which will then deal with the matter (if the traveler(s) so wishes). All personal data is treated confidentially. Flyforsinkelse.dk charges a percentage of the compensation before payment,

but otherwise this service is free of charge for the traveler.

## Terms of payment

When booking earlier than 8 weeks before departure, a minimum of 50% of the travel price is paid at the time of booking. The remaining amount is paid no later than 8 weeks before departure. When booking later than 8 weeks before departure, the full price of the trip is paid at the time of booking. Flight tickets are always paid for when booking the journey. Final settlement, i.a. for trophies not paid in advance etc. takes place after the return home, when the statement from the area/destination is available. This can vary from just a few days up to 3 months. All payments are net cash.

#### Reservation

Reservations are made for price changes caused by government intervention, exchange rate fluctuations, devaluation, external price increases or other conditions over which Jagt i Polen direkte ApS has no influence. Reservations are also made for typographical errors in the offer / descriptive material and any invoices.

# Insurances

A travel insurance covers i.a. illness, accident, transport home, liability, theft and flight delay. This form of insurance is available in many different combinations.

Cancellation insurance must always be taken out at the latest when the first deposit is paid or when another binding agreement is entered into. Weapons and other equipment are usually covered by private contents or other insurance policies. Check with your own insurance company. If you are not covered, or if you want special insurance to cover damage or theft of weapons, it is possible to take out special technical/equipment insurance.

Jagt i Polen direkte ApS recommends that you take out cancellation insurance, which is your guarantee that in the event of your own or a relative's illness, etc., right up until the time of departure, you can get the amount paid back without any other deductions than

the cancellation insurance itself. Inquire about terms and prices at Jagt i Polen direkte ApS.

#### Personal data

In order for you to enter into an agreement with Jagt i Polen direkte ApS, we need the following information: Name, Address, Telephone number, E-mail address, Date of birth, etc.

We register your personal data with the aim of being able to deliver the goods to you.

The personal information is registered with Jagt i Polen direkte ApS and stored confidentially. When personal data is collected via

www.messeserhunting.com, we ensure that it is always done by giving your consent, so that you are informed about exactly what information is collected and why, this information is deleted when we do not need it them cf. the legislation.

#### Health

Many hunting events are conducted in primitive conditions. Be it in wastelands and remote areas and in countries where the healthcare system is at a relatively low level. It is your own responsibility to ensure that you can complete the trip. Although Jagt i Polen direkte ApS is helpful with information, it is your own responsibility to familiarize yourself with which recommendations and requirements for vaccinations etc. are linked to the countries you will be traveling to.

# Personal responsibility - foreseeable risk

You must be aware that when you hunt abroad - you are moving around in nature that is unknown to you. There can be steep slopes, loose stones, all kinds of creepers and changing weather conditions. You may be exposed to our business partners making you aware that what you embark on is your own responsibility - there is a foreseeable risk that something could happen. Some of our business partners will ask you to sign this - others, like us, will make you aware of the facts. Jagt i Polen direkte ApS cannot be held

responsible if you fall, get injured, need urgent medical attention, or the like. You assume a responsibility for your own life and health that you cannot insure against - and you cannot hold our business partners or Jagt i Polen direkte ApS responsible for this.

#### **Hunting license and insurance**

You must have a valid Danish hunting license if you want to hunt within the EU. Most countries require this, and liability insurance is usually attached to the hunting license, which covers insurance matters in connection with hunting throughout Europe - but there is no insurance cover outside of Europe. In some countries it is not a requirement to have a hunting licence, in this case you must take out separate insurance that covers the hunt.

#### **Complaints**

Any complaints about hunting arrangements, accommodation, hunting staff, guides, trophy measurement, or other matters must be submitted in writing to Jagt i Polen direkte ApS within 8 days of the end of the trip - This is a prerequisite for a complaint to be processed. Any complaints that relate to conditions at the travel destination must, in order to be processed, be submitted on the spot and recorded. Submit the complaint and tell Jagt i Polen direkte ApS as soon as you can and no later than 8 days after returning home that you have submitted a written complaint to the destination. Complaints relating to accommodation, hunting conditions etc. Must be notified immediately by telephone or e-mail to Jagt i Polen direkte ApS. If Jagt i Polen direkte ApS is not made aware of this during the stay, rectification / refund is not possible.

#### **Trophy fees**

Trophy fees for the individual countries and events are given in different currencies. Refunds are not provided for packages where all game species are not shot.

# Trophies/shipping

Jagt i Polen direkte ApS cannot be held responsible for the agreements you enter with conservators abroad or in Denmark - this applies both to the performance of the professional work and to the return of the trophies. Jagt i Polen direkte ApS is not contractually bound to specific conservators, which is why we cannot take responsibility for any errors, loss, destruction, or delays of trophies that occur at the conservator in question. If the individual hunter chooses a conservator other than the one appointed by Jagt i Polen direkte ApS, it is the individual hunter's own task to arrange all collection and dialogue with the conservator in question so that the collection takes place on site before departure.

#### **Allegations**

It always has a consequence to shoot a piece of game - the conditions and regulations of the individual areas / countries will apply. However, if you shoot a piece of game that has not been recovered, you must pay for the animal in question. It is your own responsibility as a hunter to deliver a safe shot.

# Weapons permits

For weapons that require a permit, you must have a possession or carry permit if you wish to bring the weapon on a hunt abroad. From 1 April 1995, you must hold an EU firearms passport, for use when traveling between EU countries. Jagt i Polen direkte ApS can assist you with the necessary documents for the export and import of weapons across national borders. You must also use your EU firearms passport if you bring firearms to Africa.

# Interruption of stay

If for one reason or another you leave the area before the time, no refund will be made.

Repayment does not necessarily take place. Be aware that some areas will not pay back if they judge that the hunter has been led to a fair chance. For example, when shooting a piece of game or in the case of several obvious chances and when a shot is fired, the individual area can demand full payment, if it is estimated that the game is damaged or otherwise affected by the situation, which gives rise to

payment for the individual piece of game.

Jagt i Polen direkte ApS conveys hunting experiences and not game and trophies. Weather, wind, your skill as a hunter and other unpredictable conditions are important factors that determine the success of your hunting trip.

#### The organizer's responsibility

Jagt i Polen direkte ApS cannot be held responsible for unused holiday activities, including pre-booked events, lost earnings, costs for transport from the airport, etc., which are due to delays due to force majeure, weather or other circumstances beyond the organizer's control.

Jagt i Polen direkte ApS also reserves the right to change the time of the return journey, due to weather and/or traffic conditions, without the traveler being entitled to any form of compensation for unused holiday activities.

Any participation in events organized or referred by Jagt i Polen direkte ApS is at the traveler's own expense and risk. Jagt i Polen direkte ApS will never be held liable for damages to its own or third parties as well as material damages.

When booking the trip and paying the deposit, you automatically accept these conditions.
